**NATIONAL “OPT OUT” WEEK FOCUSES ATTENTION ON
CONTROVERSIAL *No Child Left Behind Act***

PHILADELPHIA, PA [or insert your own city and state]- From September 20th - 24th, a coalition of peace, social justice, and counter-recruitment groups across the country known as the National Network Opposing Militarization of Youth are sponsoring National “Opt-Out” Week to call greater attention to the military recruitment provision of the controversial No Child Left Behind Act that was enacted last year. Attendees of the Stopping War Where It Begins: Organizing Against Militarism in Our Schools conferences held in June of 2003 and June 2004 in Philadelphia join together to help educate and inform parents, teachers, and school administrators of the little known fact that, although the Act requires school districts to share students’ names, addresses, and telephone numbers with military recruiters, parents and students also have the right to “opt out” of having their private information released.

Many school districts around the country are either not aware of the Act and their legal obligations, or have chosen to not fulfill their mandate to allow “opting-out”. As a result, many students and parents don’t know about the provision or are discovering after the fact that military recruiters are in possession of their information.

Local actions by peace group include leafleting, demonstrations, and teach-ins. [this is where you can include your local activity information]

National “Opt-Out” Week also highlights such related issues as recruitment fraud, the true costs of JROTC and its recruitment connections, misinformation about the Delayed Enlistment Program, and the Armed Services Vocational Aptitude Battery in public schools, which also provides the military with families’ personal, private information.

National “Opt-Out” Day is an opportunity for both education regarding the law and a chance to help counter the growing, misleading portrayal of the U.S. military as a safe, beneficial and alternative jobs program.

There are many national, regional, and local organizations endorsing this day, including: American Friends Service Committee (AFSC); Madison Area Peace Coalition (WI); Coalition Against Militarism in Schools (CAMS – CA); YAYA Network (Youth Activists; Youth Allies - NY); Proyecto Guerrero Azteca (CA); Central Committee on Conscientious Objectors (CCCO); TeenPeace (WA); and Project YANO (Youth and Non-military Opportunities - CA).

Background on the No Child Left Behind Act. NCLB text and analysis from the Resource Center for Non-Violence (www.rcnv.org)

Text of the “No Child Left Behind” Military Recruitment Provisions:

This text is from section 9528 on pages 559 and 560 of the 670-page reauthorization of the Elementary and Secondary Education Act (ESEA), commonly known as the No Child Left Behind Act of 2001:

SEC. 9528. ARMED FORCES RECRUITER ACCESS TO STUDENTS AND STUDENT RECRUITING INFORMATION.

(a) **POLICY-**

(1) **ACCESS TO STUDENT RECRUITING INFORMATION-** Notwithstanding section 444(a)(5)(B) of the General Education Provisions Act and except as provided in paragraph (2), each local educational agency receiving assistance under this Act shall provide, on a request made by military recruiters or an institution of higher education, access to secondary school students names, addresses, and telephone listings.

(2) **CONSENT-** A secondary school student or the parent of the student may request that the student’s name, address, and telephone listing described in paragraph (1) not be released without prior written parental consent, and the local educational agency or private school shall notify parents of the option to make a request and shall comply with any request.

(3) **SAME ACCESS TO STUDENTS-** Each local educational agency receiving assistance under this Act shall provide military recruiters the same access to secondary school students as is provided generally to post secondary educational institutions or to prospective employers of those students.

(b) **NOTIFICATION-** The Secretary, in consultation with the Secretary of Defense, shall, not later than 120 days after the date of enactment of the No Child Left Behind Act of 2001, notify principals, school administrators, and other educators about the requirements of this section.

(c) **EXCEPTION-** The requirements of this section do not apply to a private secondary school that maintains a religious objection to service in the Armed Forces if the objection is verifiable through the corporate or other organizational documents or materials of that school.

(d) **SPECIAL RULE-** A local educational agency prohibited by Connecticut State law (either explicitly by statute or through statutory interpretation by the State Supreme Court or State Attorney General) from providing military recruiters with information or access as required by this section shall have until May 31, 2002, to comply with that requirement. **Opt-Out and Opt-in Policies. From the Resource Center for Non- Violence (www.rcnv.org):
Overview - Opt Out & Opt In:**

Most schools administer this Act using an OPT OUT procedure: It is presumed the school that student contact information will be given to recruiters unless parents take the initiative to opt out. Notification of parents about their consent option ranges from total neglect to a form letter. If, as is often the case, a parent does not receive or respond to notification, contact information for their child will be given to recruiters...and their student will have to deal with recruiter marketing at school and at home!

If your school is using Opt Out —

- 1) Be sure the Opt Out notice is aggressively advertised and circulated to all families. This is a school administration job, but some peace action communities are actively leafleting students and parents with Opt Out letter which parents can complete and return to school administrators.
- 2) Be sure the notification letter is translated into a language use by parents, and
- 3) written so that people can understand it.

Action ideas for National “Opt-Out” Week

•flying during the week at or near schools, shopping centers, the board of education, etc. •press conference with students, parents, teachers and allies to announce the day’s activism against the NCLB •rally/demonstration •wearing armbands/ribbons/signs in school calling for students to Opt-Out •cultural events (musical performances, peace art, etc.) •political street theater •teach-ins, “town hall” community forums on the NCLB •tabling with factsheets, sample Opt-Out letters, counter- recruitment resources •non-violent civil disobedience (lockdowns in front of recruiter offices, the board of ed., etc.)

SAMPLE FLYER TEXT

(provided by Arlene Inouye, Human Rights Committee Co- Chair, United Teachers Los Angeles):

YO - L.A. STUDENTS - LISTEN UP! Do you want the military down your neck?

A new Bush administration law gives MILITARY RECRUITERS access to YOUR INFORMATION (the names, addresses and telephone numbers of juniors and seniors in high school), UNLESS YOU OPT-OUT!

What is OPT-OUT? It is your legal right to notify your school that you DO NOT want the military to receive your personal information.

IT IS YOUR CHOICE to keep your information private, while letting your name, address, and telephone number to be given to colleges, universities, and employers.

When do you OPT-OUT? Opting out must be done EVERY school year. This year the window of time is between SEPT. 15th and SEPT. 24th. It is important that you tell your school you want to OPT-OUT within this time frame. Juniors and seniors should be mailed the form in English and Spanish. If you need other languages - tell your school.

WHY SHOULD YOU OPT-OUT? Military recruiters do not give a balanced picture about what it means to join the military. They are salesmen - They make \$\$\$ off you. Do not let them hassle you! Get the facts about what it means to join the military before you have recruiters down your neck.

HELP GET THE WORD OUT- Parents and students should know of their rights to privacy from military recruiters. Tell them about opting out!

Across the nation, students and activists are taking action, saying **NO** to increased militarization of our schools.

The No Child Left Behind Act

is a sweeping reform of public education signed into law by President G. W. Bush January 2002. One provision of this act requires that public schools hand over student contact lists to military recruiters, **so the military recruiters can reach you at your home.**



Your school is required to notify you in writing that you can **Say NO and Opt Out** of having your name given to military recruiters.

If you want to do something about it, this is your local group.

Things You Need to Know:

Schools: students have the right to privacy and protection from harassment by military recruiters.

Students: you need to write to your school officials and tell them you do not want your contact information handed out to military recruiters, or it will be.

Parents: you need to be aware that military recruiters are as relentless as any other telemarketer and will use YOUR private information to contact your child.

SAMPLE BI-LINGUAL FORMS FOR OPTING OUT

Act to Protect Your Privacy from Military Recruiters

You may be harassed at home by military recruiters because your name, address and phone number will be given to them by your school — unless you tell your school to not give out the information. To exercise your legal right to have this information kept private, you should notify your school office as soon as possible. Some school districts may provide their own forms for this, but they must obey your request no matter how you submit it. You can write your own letter or use the one below. Use a letter or form for each individual student and keep a copy. It is not required by law, but we recommend having a parent or guardian also sign:

1. **Obligación de proveer información a los oficiales de Reclutamiento:**
